



CHASING GREATNESS FUND CAMPAIGN

TERMS & CONDITIONS

Summary

The Port Adelaide Football Club (PAFC) was established in 1870 in the working-class suburb of Alberton, to the west of Adelaide. From humble beginnings on the docksides of Port Adelaide as a sporting social club for the young men of the district, Port Adelaide has grown into one of the nation's most famous professional sporting organisations. Our record of success is unparalleled – 4 Champions of Australia titles, 36 SANFL Premierships, 1 AFL Premiership.

Today we compete in both the elite Australian Football League (AFL) and the local South Australian National Football League (SANFL) as a foundation club of the local league. Port Adelaide Football Club lives to the charter to compete and win in the biggest competition in the land, representing its community with pride and passion.

The Chasing Greatness Fund has been established as a registered project with the Australian Sports Foundation (ASF) to ensure the PAFC is able to invest in football, invest in facilities and remain sustainable with financial independence for the next generation.

The ASF was established by the Australian Government to raise funds through public and corporate donations for the development of sport in Australia. The ASF's specific listing in the Income Tax Assessment Act (1997) (Subdivision 30-B, s30-90) means donations to them of \$2 or more are tax deductible. The Chasing Greatness Fund is a project of PAFC and is registered with and conducted under the charter of the ASF.

A donor can choose from one for 4 levels of monthly donations, based on a pledge/commitment model. With a total 22,500 donors making varied monthly donations from \$5 - \$30 per month over 52 months the PAFC will have fundraised \$13M.

1. Donation

1.1. Your Chasing Greatness donation will continue until the end of the campaign on 1 November 2025 unless terminated earlier. To be part of the Chasing Greatness fund you will require internet access to track the success of the program and provide us with one or more Payment Methods. "Payment Method" means a current, valid, accepted method of payment, as may be updated from time to time, and which may include payment through your account with a third party. Unless you cancel your donation before your next donation date, you authorize us to charge the donation amount for the next donation cycle to your Payment Method (see "Cancellation" below).

1.2 You acknowledge that your donation is made unconditionally to the ASF, the preferred beneficiary is the **Port Adelaide Football Club Chasing Greatness Fund**. By making this donation you accept the ASF's [Terms and Conditions](#) and [Privacy Policy](#). **The Chasing Greatness Fund** is a project of **PAFC** (ABN 49 068 839 547) and is registered with and conducted under the charter of the ASF (ABN 27 008 613 858).

2. Donation and Cancellation

2.1. Donation Cycle. The donation amount for the Chasing Greatness Fund and any other charges you may incur in connection with the campaign, such as possible transaction fees, will be charged to your Payment Method on the specific payment date indicated on the payment page. The length of your donation cycle will be 52 months (unless terminated earlier) on the type of subscription that you choose when you sign up to make the donation. In some cases your payment date may change. **Your donation will be debited monthly until the conclusion of the campaign (31 October 2025) or until the PAFC campaign fundraising target of \$13,000,000 is reached, whichever occurs sooner. Donors will be debited for a maximum of 52 months."**

2.2. Payment Methods. To be part of the Chasing Greatness Fund you must provide one or more Payment Methods. You authorize us to charge any Payment Method advised by you in case your primary Payment Method is declined or no longer available to us for payment of your donation amount. If a payment is not successfully settled, due to expiration, insufficient funds, or otherwise, and you do not cancel your account, you will be contacted by the PAFC. For some Payment Methods, the issuer may charge you certain fees, such as foreign transaction fees or other fees relating to the processing of your Payment Method. Transaction charges may vary depending on the Payment Method used. Check with your Payment Method service provider for details.

2.3. Updating your Payment Methods. You can update your Payment Methods by contacting our membership services team on 08 8447 4044 or email at membership@pafc.com.au. We may also update your Payment Methods using information provided by the payment service providers. Following any update, you authorise us to continue to debit the applicable Payment Method(s).

2.4. Cancellation. You can cancel your donation to the Chasing Greatness Fund at any time, and you will continue to be acknowledged as a founding member. To the extent permitted by the applicable law, payments are non-refundable and we do not provide refunds or credits. To cancel you will need to contact our membership services team via phone 08 8447 4044 or email membership@pafc.com.au.

3. Chasing Greatness Fund

3.1. You must be at least 18 years of age to become a donor and make a donation to the Chasing Greatness Fund. Minors may only become a donor with the approval of a parent or guardian and make a donation under the supervision of an adult.

3.2. Your donation is made unconditionally to the ASF for the benefit of the PAFC Chasing Greatness Fund. Donations of \$2 or more to the ASF are tax deductible.

3.3. A tax deductible receipt for each monthly donation will be issued by the ASF to your nominated email address. All claims for a tax deduction are subject to being accepted by the Australian Taxation Office, who can be contacted for professional advice if either an individual or business is uncertain of their taxation position.

3.4. The Chasing Greatness Fund has been developed to secure pledges from our supporters over a 52-month period commencing 14 May 2021 – concluding by 31 October 2025 with a

campaign termination date of 1 November 2025. Irrespective of when you join the campaign, no donations will be debited post 31 October 2025 for your monthly commitment.

4.3. Information to be Provided. You must provide the requested information for donation to the Chasing Greatness Fund including your name, email address and Payment Methods, on the Chasing Greatness website and you certify that information provided by you will be correct.

4.4. Privacy of Information. Information provided by you as a donor on the Chasing Greatness website will be retained by PAFC and will be available to the administrator of the Chasing Greatness website and will be provided to the ASF.
